

## **“Timson Trade 2017 Holiday Raffle” Terms & Conditions**

1. The “**Timson Trade 2017 Holiday Raffle Promo**” promotion (“Promotion”) of Timson Securities Inc. “TSI” runs from **September 1, 2017 to December 31, 2017**, both dates inclusive of the promotion period. (“Promo Period”).
2. This Promotion is open to all Timson Securities Inc. “TSI” online clients (“Eligible Client”).
3. The following persons shall not be eligible to participate in this promotion:
  - Employees and trading representatives of Timson Securities Inc. up to second degree of consanguinity and affinity
  - Timson Securities Inc. clients whose accounts have been suspended, cancelled or terminated
4. Joint accounts are entitled to participate in the Promotion, but are treated as one (1) account only.
5. During the promo period, eligible clients can accumulate raffle entries with their traded value with Timson Securities Inc. in the ratio of **Php100,000.00 gross value traded: 1 raffle entry**. *(Example: If Client A has a total gross traded value of Php1,000,000 for the month of September, he/she gets 10 raffle entries).*
6. TSI will draw a winner via an electronic raffle draw in TSI’s office on **October 2, 2017, November 2, 2017, December 4, 2017, January 3, 2017**, with the winner to be announced the day after the raffle draw. TSI will notify the winner via email and SMS.
7. Monthly raffle prizes are to be in the form of **SM Gift Certificates worth Php5,000.00** each. Prizes are not convertible to cash and are not transferable to anyone aside from the winner.
8. Winners cannot win more than once.

9. Winners can claim the raffle prizes at TSI's office at **Suite 3310 Robinsons Equitable Tower ADB Avenue Ortigas, Pasig City 1605 Philippines**. Winners can authorize a representative to claim the prize on their behalf (Requirements: Signed authorization letter, Photocopy of a valid government-issued ID of the winner, Photocopy of a valid government-issued ID of the representative). The prize will be forfeited in favor of Timson Securities Inc. if it is not claimed by **March 30, 2018**.
10. Non-winning raffle entries can still participate in the succeeding raffle draws on the following months.
11. The winners agree that TSI may publicize the name and photograph of the winners in such mode and manner as TSI considers fit. The winners' names may be published on TSI's website & social media channels such as Facebook and Twitter.
